

Certificate of Exemption – AGAR 2019/20 Part 2

 - issued a public interest report in respect of the authority or any entity connected with it
 - made a statutory recommendation to the authority, relating to the authority or any entity connected with it
 - issued an advisory notice under paragraph 1(1) of Schedule 8 to the Local Audit and Accountability Act 2014 ("the Act"), and has not withdrawn the notice
 - commenced judicial review proceedings under section 31(1) of the Act
 - made an application under section 28(1) of the Act for a declaration that an item of account is unlawful, and the application has not been withdrawn nor has the court refused to make the declaration
- The court has not declared an item of account unlawful after a person made an appeal under section 28(3) of the Act.

If you are able to confirm that the above statements apply and that the authority neither received gross income, nor incurred gross expenditure, exceeding £25,000, then the Certificate of Exemption can be signed and a copy submitted to the external auditor **either** by email **or** by post (not both).

The Annual Internal Audit Report, Annual Governance Statement, Accounting Statements, an analysis of variances and the bank reconciliation plus the information required by Regulation 15 (2), Accounts and Audit Regulations 2015 including the period for the exercise of public rights still need to be fully completed and, along with a copy of this certificate, published on a public website* before 1 July 2020. **By signing this certificate you are also confirming that you are aware of this requirement.**

Explanation of variances

Cheque number 000403 dated 11th March 2019 was not presented to the NatWest Bank therefore at the beginning of the financial year, 2020-2021 there was an increase of £35.00.

Harrington Parish Council obtained a grant of £7300 in December 2019 in order to prepare a Neighbourhood Plan.

The invoices from the consultancy firm YourLocale included VAT to a total of £1400, which exceeded the grant. Adjustment was made by transferring reserve money to the current account to pay for invoice.

The VAT was claimed in March but had not been received at the end of the financial year.

Thus the Neighbourhood Plan accounts distorted the accounts for the financial year 2019-20.
